- 1. The entire Fire Protection system installed at the site should be maintained in excellent working condition for any fire emergency.
- 2. The Fire Extinguisher handling and Operational training to be imparted to the Teaching / Non-Teaching staff.
- 3. You will carry out testing, maintenance & refilling of all Fire Extinguisher / Fire Protection Systems from competent person and necessary Form-B certificate regarding the maintenance & operational condition of the firefighting system to be submitted to the fire office as per the Section -3 (3) of the Fire ACT 2016, for every six months in month of January to July, failing of which this NOC shall be treated as cancelled.
- 4. You will keep all the static water tanks full for any fire emergency.
- 5. Fire/Emergency Evacuation Mock Drill should be carried out in the school once in every six months.
- 6. You will keep all passages and corridors free from any obstructions and combustible material
- 7. "No Smoking Board", "Emergency Exit", "Emergency Contact Number of Fire policy", "MSEB", "Ambulance" in Assembly Area shall be always displayed to avoid/minimize fire / emergency situation / risks.
- 8. You have to keep fire protection system (fire extinguishers) easily accessible and visible as well as healthy and good working condition.
- 9. This NOC is issued only from the fire safety point of view. It cannot be treated for any other purposes however necessary permission from the statutory authorities should be obtained.
- 10. You are not permitted to construct the school building's remaining floors in the school working hours.
- 11. All the rules, regulations declared time to time from the PCMC or Govt. of Maharashtra shall be binding on you and any violation of these shall be viewed seriously.
- 12. This Fire is valid up to 20.02.2025 only and renewal of these NOC should be before above-mentioned date with respect to full fill all mandatory conditions.
